- 1. All persons sanctioned with the New Haven County USBC Bowling Association are eligible to bowl in this tournament. Any bowlers holding a PBA membership card are eligible to bowl in this tournament with the following provisions: Only one card holder will be allowed to bowl on a two person team and no more than two card holders would be allowed to bowl on a four person team.
- **2.**The tournament shall be conducted on a handicap and non handicap basis with the handicap being determined as 100% of the difference of the bowlers average and 250. The average determination is as follows. 2023/2024 winter average minimum 21 games, if no winter average then 2024 summer average min 21 games. If bowler has neither then use average as of Oct..27th 2024 min 21 games, if not bowler will bowl scratch.

League standing sheets will be required for all bowlers using their avg as of Oct.27 2024 in all their leagues.

Youth averages will be accepted. ALL AVERAGES WILL BE VERIFIED. TOURNAMENT MANAGEMENT HAS THE RIGHT TO RAVERAGES ACCORDING TO USBC RULE 319.Ten pin rule is waived for these tournaments.

- **3. SPORT/CHALLENGE CONDITION BOWLERS:** If a bowler has both a sport/challenge condition average and a non sport coaverage for the year, the non sport average will be used. If a bowler has only a sport/challenge condition average, the convinted used in the USBC rule book will be used.
- **4.**The prize fund will be returned 100% with 50% of prize money in each event (except all events) allocated to handicap prizes. All fees collected for All Events scratch and All events handicap will be returned to their respective divisions. **5.**In case of ties for any first place finish, co-champions will be declared. Award will be awarded to all champions.
- 6. Bowlers will be allowed multiple entries in all of the events; unlimited team, doubles, and singles with the exception of the optional "all Events" award, which may only be entered once. In case of doubles, a team can only cash once with the same partner. In the case of four person team, only two common bowlers (per team) will be allowed to cash. A bowler can only cash once in singles event, hdcp or scratch receiving the higher prize.
- 7. When a bowler competes in more than one singles, doubles, or team, their first scores count towards their A/E total
- **8.**Team captains shall report to the tournament management 30 minutes prior to bowling to check in and verify line-ups. Lane assignments will be drawn by team captains.
- **9.** These and other rules deemed necessary by the Tournament Management shall govern.
- **10**.WARNING TO ALL YOUTH BOWLERS: you may jeopardize your amateur standing by bowling in this tournament or any other tournament where cash prizes are awarded.
- 11. Prize monies shall be distributed within 30 days of the completion of the tournament and the verification of averages.
- **12.Dress code.** The team captain is responsible for his or her team members to follow the dress code as stated Participants (male and female ) must wear a shirt with a butterfly collar or mock collar. U.B.A. shirts will be allowed providing they have sleeves, if the U.B.A. shirts have no sleeves, the bowler must wear a shirt with sleeves underneath Men may wear slacks, casual trousers or jeans. Women may wear skirts, slacks, casual trousers, skorts, culottes, or jeans. All clothing (mens or womens) must be neat, clean and have no holes or tears. Dress or casual shorts are allowed.

Clothing not allowed, cut off shorts, sweats, parachute pants and yoga pants. No hats are to be worn.

No profanity or vulgarity will be allowed on any clothing

- 13. All above rules apply unless specified in this section.
- 14. Only women bowlers are allowed in this division.
